- 2 Special handling is mandatory for Unaccompanied Minors aged from 5 to under 12 years old.
- 3 Dispensation for special handling can be obtained for Unaccompanied Minors above 12 years and below 18 years if parental consent is given. In such an instance, a "Unaccompanied Minor Assistance & Handling Waiver" has to be signed by the parent/guardian for each outward and return journey.
- 4 Carriage of Unaccompanied Minors shall be subject to SIA's General Conditions of Carriage (GCC) and Conditions of Contract (COC), which can be found on <a href="https://www.singaporeair.com">www.singaporeair.com</a> and they shall prevail to govern SIA's rights and remedies.
